RESOLUTION NO. 22-23-19 Series of 2023

RESOLUTION TERMINATING THE GRANT OF FIVE THOUSAND PESOS (P5,000.00) ASSISTANCE TO MEMBERS AFFLICTED BY COVID-19 VIRUS EFFECTIVE JULY 1, 2023

WHEREAS, in 2019, a new corona virus was identified as cause of disease outbreak that originated in China 2019;

WHEREAS, the virus is known as severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) and called coronavirus disease 2019 (Covid-19) and was declared by the World Health Organization (WHO) as outbreak of pandemic;

WHEREAS, in the Philippines, the Covid-19 pandemic afflicted millions of Filipinos that caused the death of thousands of its citizens;

WHEREAS, on March 30, 2020, the BJMPMBAI immediately acted and approved Board Resolution No. 19-20-06 giving assistance of P5,000.00 each to Association's members infected by the disease;

WHEREAS, the assistance extended by the Association to members from 2020 to the first five (5) months of 2023 was Thirteen Million Three Hundred Ninety-Five Thousand Pesos (P13,395,000.00);

WHEREAS, because of the decreasing number of Covid-19 cases, the Department of Health issued Department Memorandum No. 2022-0141 on March 31, 2022, on transition to the endemic phase of Covid-19 characterized by persistently low levels of community transmissions with sporadic outbreaks that effectively lifted the State of Calamity or Public Health Emergency of the country.

WHEREFORE, based on the foregoing, on motion by Trustee Antonio O Gerente, seconded by Trustee Victorino M Onato, the Board RESOLVED, as it hereby RESOLVES, to terminate the granting of Five Thousand Pesos (P5,000.00) assistance to members infected with Covid-19 based on Department of Health Memorandum No. 2022-0141 dated March 31, 2022. This Resolution shall take effect July 1, 2023.
