RESOLUTION NO. 21-22-15 Series of 2022

RESOLUTION PROVIDING ANNUAL MEDICAL AND DIAGNOSTIC EXAMINATION (AMDE) TO BJMP RECRUITS THAT TOOK THEIR OATH OF OFFICE AND THEREAFTER REGISTERED AS MEMBERS OF THE ASSOCIATION

WHEREAS, the Association is providing several benefits free of charge to its members although, it has a standing policy that a member is entitled to receive the benefits if he/she is a member of BJMPMBAI for at least one (1) year and paid the monthly premiums;

WHEREAS, during the 2022 Annual Medical and Diagnostic Examination (AMDE) conducted by the Association, some BJMP Regional Offices allowed their new recruits to undergo the examination with the cost individually shouldered by them;

WHEREAS, new recruits of BJMP, do not possessed the BJMPMBAI requirement of one (1) year membership hence, disqualified to receive the Annual Medical and Diagnostic Examination and the issue on the examination by the new recruits arose after they requested for reimbursement of the amount they paid to service provider which was denied by the Association;

WHEREAS, some BJMP Officers and active personnel were not convinced for the reason of denial and argued that all active BJMP personnel must be entitled to the AMDE benefit, until the Board of Trustees took cognizance of the issue and discussed the problem;


WHEREAS, the issue was discussed for two (2) consecutive Board meetings until Trustee Leopoldo Morante Jr on the second meeting suggested that BJMP new recruits be allowed to undergo free Annual Medical and Diagnostic Examination after taking their oath of office and payment of at least one (1) month contribution.

WHEREFORE, after discussions and deliberation, on motion by Trustee Leopoldo D Morante seconded by Trustee Armando M Llamasares, the Board RESOLVES, as it hereby RESOLVED, to authorize the granting of AMDE benefit to recruits who took their oath of office and paid at least one (1) month membership contribution to be effective upon approval.
