RESOLUTION APPROVING THE GRANT OF OLD AGE GRATUITY CARE PACKAGE PROGRAM TO MEMBERS SIXTY (60) YEARS OLD AND ABOVE

WHEREAS, personnel of BJMP and their dependents who joined the Association some twenty (20) years ago have now reached senior years but still opted to remain as members of BJMPMBAI;

WHEREAS, the contribution they made during the early days of the Association up to the present can never be quantified as they are the backbone of the BJMPMBAI membership that basically shaped the Association into what it is now;

WHEREAS, the Association is mandated to perform acts calculated to support its members to accomplish its purpose and one of these deeds is to recognize the loyalty and trustworthiness of its senior members age sixty (60) years old and above;

WHEREAS, based on this premise, the Social Services Committee crafted a guideline to grant an old age gratuity care package to senior members sixty (60) years old and above with drawn out cash to be given on or before their birth dates as a memento of endearing care from the Association;

WHEREAS, the guiding principle also defined who are the members entitled to the package, the procedure to avail the gratuity care and the requirements;

WHEREAS, it also included a matrix showing the number of regular members and Associate members entitled to the grant, with age bracket and the amount to be received following the graduated amount of P3,500.00 to P20,000.00;



WHEREFORE, after due discussions and deliberations and on motion by Trustee Leopoldo D Morante Jr, seconded by Trustee Armando M Llamasares, the Board RESOLVED, as it hereby RESOLVES, to approve the Grant of Old Age Gratuity Care Package to members Sixty (60) years old and above to take effect on January 1, 2023. RESOLVED FURTHER, that the grant shall be given every year. RESOLVED FINALLY, that a copy of this approved resolution be attached to the approved guidelines.


