## **RESOLUTION NO. 21-22-19 Series of 2022**

**RESOLUTION APPROVING THE ADVANCE AVAILMENT OF FUNDING FROM 2023 ANNUAL MEDICAL AND DIAGNOSTIC EXAMINATION AMOUNTING TO THREE HUNDRED FORTY-FOUR THOUSAND PESOS (P344,000.00) FOR THE LABORATORY EXAMINATION OF ONE HUNDRED SEVENTY TWO (172) ACTIVE PROMOTABLE/MEMBERS**

WHEREAS, Ex-Officio member of the Board of Trustees SJ04 Leander Sumampong informed the Board that the Bureau of Jail Management and Penology issued a memorandum dated October 20, 2022 informing that the 172 qualified applicants for promotion will be facilitated by the BJMP National Human Resource Merit Promotion and Selection Board;

WHEREAS, one of the requirement for the promotion is the submission of laboratory and medical results of the applicants not later than November 17, 2022;

WHEREAS, Ex-Officio Sumampong remarked that the 172 promotable are requesting the BJMPMBAI to finance their laboratory and medical examination amounting to Three Hundred Forty-Four Thousand Pesos (P344,000.00) by advancing the funding from the 2023 AMDE;


WHEREAS, Trustee Leopoldo D Morante commented that the funding of the 2022 AMDE was already exhausted and clarified that if the instant request will be granted, the funding will be taken from 2023 AMDE and the 172 members will no longer qualified to the 2023 AMDE regular medical and laboratory examination for the rest of the year and they will shoulder the cost if they need another examination for 2023.

WHEREFORE, after due discussions and deliberation and on motion of Ex-Officio Leander Sumampong seconded by Trustee Leopoldo D Morante Jr, the Board **RESOLVED**, as it hereby **RESOLVES**, to approve the request of One Hundred Seventy Two (172) promotable to undergo medical and diagnostic examination by advancing the amount of Three Hundred Forty-Four Thousand Pesos (P344,000.00) from the 2023 Annual Medical and Diagnostic Examination (AMDE) funding. **RESOLVED FURTHER**, that the 172 members are no longer qualified to avail the benefit for the rest of the year. This Resolution shall take effect upon approval.


