## RESOLUTION NO. 2023-21 Series of 2023

### RESOLUTION INCREASING THE APPROPRIATION FOR THE BJMPMBAI 2024 ANNUAL HEALTH CARE ASSISTANCE PACKAGE (AHCPA) PROGRAM

WHEREAS, the Bureau of Jail Management and Penology (BJMP) is conducting the annual physical and medical examination of its personnel to ensure that only those who are physically and mentally fit shall composed the BJMP jail corps,

WHEREAS, as a gesture of support to the Fitness Program of the Jail Bureau, the Association, in 2019 and in coordination with the BJMP started to provide free physical and medical examination to BJMP personnel;

WHEREAS, this was made possible with the BJMPMBAI entering into an agreement with BJMP and the accredited DOH laboratory clinics as Service Providers nationwide;

WHEREAS, in 2020, Ten Thousand Four Hundred Eighty-Nine (10,489) active, retired and associate members benefitted from the program while in 2021, Ten Thousand One Hundred Twenty-One (10,121) members availed the benefit and in 2022, Thirteen Thousand One Hundred Ninety-Six (13,196) members had undergone the laboratory examination and finally this year, Eighteen Thousand Seven Hundred Seventy-Three (18,773) members decided to avail the BJMPMBAI program;

WHEREAS, next year or in in 2024, the Association is expecting an increase of 5,000 members that needed P2,000.00 appropriation each and for additional P10M requirement to provide the free laboratory examination to all members.


