## RESOLUTION NO. 2021-24 Series of 2021

### RESOLUTION GRANTING ENHANCED COMMUNITY QUARANTINE (ECQ) HAZARDOUS PAY TO ALL BJMPMBAI EMPLOYEES

WHEREAS, before the end of July 2021, the government announced that the NCR Bubble and other provinces and cities nationwide will be placed under the Enhanced Community Quarantine starting August 6, 2021 for two (2) weeks or until August 20, 2021;

WHEREAS, the strictest and most stringiest classification of community quarantine was approved by the President following the recommendation of the IATF and the Department of Health to stem the surge of the Covid-19 pandemic;

WHEREAS, with the imposition of ECQ over the National Capital Region and other areas, it is expected that it would restrict the movements of the citizens especially the working class like the employees of the Association because of various protocols that will be enforced;

WHEREAS, to help the BJMPMBAI employees cope with the restrictions, it is just proper to help them prepare for the worst by providing them a financial cash assistance to overcome the consequence of the quarantine period.

WHEREFORE, on motion by Director Armando M Llamasares, seconded by Director Leopoldo D Morante Jr, the Board, **RESOLVED**, as it hereby **RESOLVED**, to grant all BJMPMBAI employees whether regular or not a one-time hazardous pay distributed as follows:

- a. P10,000.00 for General Manager, Compliance Officer, Internal Auditor and Division Chiefs; and
- b. P5,000.00 for all other staffs.


**RESOLVED FINALLY**, that this Resolution shall take effect immediately.
