


### RESOLUTION AUTHORIZING THE ENROLLMENT OF THE ASSOCIATION TO THE ELECTRONIC FILING AND PAYMENT SYSTEM (eFPS) OF THE BIR

WHEREAS, on December 01, 2021 the BJMPMBAI received a letter dated October 21, 2021 from Mr Arnulfo A Galapia, Revenue District Officer, Revenue District Office No. 38 of the BIR, informing the Association that it is mandatory for taxpayers included in the *Taxpayer Account Management Program (TAMP)* to make use of the *Electronic Filing and Payment System (eFPS)* facility in filing returns and making payments of taxes due;

WHEREAS, the BIR cited Section 244 of the National internal Revenue Code of 1997, as amended, in relation to Section 27 of RA No 8792 otherwise known as the "Electronic Commerce Act", Revenue Regulations No 10-2014 promulgated to amend provisions of RR No 9-2011 and last amended by RR 1-2013, and informed the Association that in view of the status of BJMPMBAI as one of the TAMP Taxpayers, it is required to enroll in the *eFPS* facility;

WHEREAS, in view of the above mandatory guidelines, this Resolution authorizes the intention of the Association to comply with the Electronic Filing and Payment System (eFPS) of the BIR

WHEREAS, as further required, the top three (3) officers of the Association with their positions and signatures are hereby submitted; hence:
