**RESOLUTION APPROVING THE BJMPMBAI IMPLEMENTING
RULES AND REGULATIONS ON MEMORIAL PLAN**

WHEREAS, on September 15, 2018, representatives of Philplans proposed a package of benefits before the members of the Board during its presentation of Memorial and Educational Plans;

WHEREAS, the presentation was followed by series of meetings, consultations and clarifications between top management officers of the BJMPMBAI and Philplans until the Memorandum of Agreement was presented for approval before the Board of Directors;

WHEREAS, the Memorandum of Agreement was signed on July 31, 2019;

WHEREAS, despite the approval of the MOA, the benefit was not implemented as the Board noted the absence of clear guidelines on procedures how the members can avail of the benefits;

WHEREAS, the Board however, acknowledged the subsequent consultations and conferences with Philplans by the Social Services Committee and some members of the Board, followed by discussions by members of the Board, the Committee on Social Services and management staff aimed at resolving the issues on Memorial Plan specifically on age requirement, named and unnamed memorial plans and benefits, accidental death and disability (AD&D), insurance benefits, claims requirements, accreditation of funeral parlors and how to distribute the plans to the members for the preparation of an Implementing Rules and Regulations;

WHEREAS, once the concerns were satisfied and complied with, the corrected copy of the guidelines was presented to this Board for consideration.

WHEREFORE, after due deliberations and discussions and on motion by Director Doris R Dorigo seconded by Director Rosendo M Dial, the Board RESOLVED, as it hereby RESOLVED, to approve the BJMPMBAI Implementing Rules and Regulations on Memorial Plan but directed that the guidelines on College Educational Plan be presented later before the Board for consideration. The Board finally directed to disseminate the information to regions and furnish them copies of Philplans' accredited funeral parlors.
