RESOLUTION INCREASING THE MONTHLY MEMBERSHIP CONTRIBUTION OF ASSOCIATE MEMBERS FROM THREE HUNDRED PESOS (P300.00) TO FIVE HUNDRED PESOS (P500.00) AND A MINIMUM OF ONE THOUSAND PESOS (P1,000.00) AS MEMBERSHIP CONTRIBUTION OF ALL ASSOCIATE AND ACTIVE MEMBERS REACHING THE AGE OF SIXTY (60) YEARS OLD

WHEREAS, it was noted that Associate/Dependent members paying Three Hundred Pesos (P300.00) as membership contributions are receiving benefits greater than they contribute to the fund of Association;

WHEREAS, aside from the cash benefit of Annual Health Care Package Assistance of P2,000.00, the Hospitalization reimbursement of at least P15,000.00 when confined in a hospital; dividend from surplus declared from time to time, the Calamity assistance of P5,000.00 in case the member's property was seriously affected by the calamity, the scholarship at STI that can enjoy by his/her children upon qualification, the amount of insurance proceeds that can be received by the beneficiaries in case the principal died, the disability benefit from SGTI and Cocolife, and the burial assistance of P50,000.00 to deceased members, the benefits received by the member far outweigh his/her P300.00 monthly membership contributions;

WHEREAS, the cash assistance received by members are considered as expense of the Association that greatly affected the BJMPMBAI revenue which must be stabilized to protect the financial position of the Association;

WHEREAS, due to the issues posed by low collection of membership dues from dependent/ associate members that pay P300.00 monthly, the Board noted the need to increase their monthly contributions from P300.00 to P500.00;

WHEREAS, the Board also noted the need to increase the minimum dues to P1,000.00 of all Associate members and Retirees when they reached the age of 60 years old to enjoy more benefits from the Association like the Old Age Cash Benefit of P3,500.00 during his/her birthdays.

WHEREFORE, based on the foregoing, on motion by Trustee Armando M Llamasares, seconded by Trustee Doris R Dorigo, the Board RESOLVES, as it hereby RESOLVED, to increase the membership contribution of Associate/Dependent members from P300.00 to P500.00 pesos while Associate and Retirees that reached the age of 60 will be required to contribute the amount of P1,000.00 monthly.


