**RESOLUTION AFFIRMING THE RELEASE OF SIXTY-FIVE THOUSAND PESOS (P65,000.00) AS PAYAPA PLAN BENEFIT TO BENEFICIARIES OF DECEASED MEMBERS**

WHEREAS, in March 2024, the Association started purchasing Payapa Plans from Philplans First, at a new rate of Seventy-Five Thousand Pesos (P75,000.00) per plan as approved by the Board of Trustees pursuant to Resolution No. 2024-06 dated February 29, 2024;

WHEREAS, the new rate of the Plan is costlier than the previous cost of Fifty Thousand Pesos (P50,000.00) which the Association is previously buying from Philplans;

WHEREAS, at the time the BJMPMBAI is still purchasing Payapa Plan at P50,000.00, the Association is releasing the amount of Forty-Five Thousand Pesos (P45,000.00) from the said amount and released it to beneficiaries of deceased members as benefits;

WHEREAS, with a higher cost of the Payapa Plan which was authorized by the Insurance Commission, the Executive Committee during its meeting last June 6, 2024, decided to adjust the amount being extended as burial assistance to deceased members and arrived at a resolution to recommend to the Board of Trustees that the amount of Sixty-Five Thousand Pesos (P65,000.00) be released to beneficiary of deceased member as assistance from the Association.

WHEREFORE, after due discussions and deliberations and on motion by Trustee Serafin P Barretto Jr, seconded by Trustee Armando M Llamasares, the Board RESOLVES, as it hereby RESOLVED, to approve the assistance of Sixty-Five Thousand Pesos (P65,000.00) burial assistance taken from the Seventy-Five Thousand Pesos per Plan purchased from Philplans for release to beneficiaries of deceased members. RESOLVED FINALLY, that the release shall take effect May 2, 2024.
