**RESOLUTION AWARDING THE PROVISION FOR JANITORIAL SERVICES TO
JAMWELL CLEANING SERVICES**

WHEREAS, when the BJMPMBAI transferred to its newly owned Corporate Office Building at Congressional Avenue Extension, Barangay Culiat, Quezon City, it was immediately confronted by issue on cleanliness and sanitation as it lacked personnel to clean its five hundred square meters (500 sqm) office floor area plus its immediate surroundings;

WHEREAS, with the daily problem of who will do the general cleaning of the office, the Restrooms, the lobby and its immediate environments during the rainy season and the dirt caused by influx of members conducting business with the Association, the Executive Committee directed management staff to conduct canvassing of proposals from Janitorial Services Providers for possible contract;

WHEREAS, based on directive of Executive Committee, the Nomination Committee member/canvasser after conducting the canvassing submitted three (3) proposals from Service Providers which are:

1. Jamwell Cleaning Services (Batasan Hills, Quezon City)
 - a. Three (3) janitorial personnel per day;
 - b. provision of equipment, supplies and cleaning materials and
 - c. Monthly payment of P70,631.08.
2. Happy Housekeepers Inc. (Muntinlupa City)
 - a. Three (3) janitorial personnel;
 - b. None supplies of cleaning materials;
 - c. Monthly payment of P71,110.97. and
3. Likes Cleaning and General Services (Conception, Cubao, Quezon City)
 - a. Three (3) janitorial personnel;
 - b. None supplies of cleaning materials;
 - c. Monthly payment of P71,693.06.

WHEREAS, based on the proposals, Jamwell Cleaning Services offered the lowest bid with additional provision for equipment and supplies of cleaning materials and its willingness to enter into a Memorandum of Agreement with the Association.


WHEREFORE, based on the foregoing, on motion by TRUSTEE ARMANDO M LLAMASARES, seconded by TRUSTEE DIONY D MAMARIL, the Board RESOLVES, as it hereby RESOLVED, to award the provision for Janitorial Services to Jamwell Cleaning Services that submitted the lowest bid/proposal with three (3) of their personnel doing the job with equipment, supplies and materials for cleaning and for a monthly charge of Seventy Thousand Six Hundred Thirty-One Pesos and Eight Centavos (P70,631.08) per month. RESOLVED FINALLY, to direct the President of the Association to enter into MOA with Jamwell Cleaning Services for approval of the Board.
